Sheriff has been in conversation with the Auditor on the 911 levy. Fire departments have asked them to pay the MARCS fees. If you do one then need to add Police Departments as well as EMT's. Estimated \$100,000. Next Gen 911 is coming in a few years, mandatory. No cost known at this time. Commissioners asked if tax payers will say we are over taxed and over equipped? Not against Marcs fees but to include in a 911 levy? Next Gen is mandatory and funds will be needed put back for that when the time comes. Sheriff is considering a ¾ replacement and will discuss with the Auditor. A couple of deer crashes recently. Five inmates are being housed in other counties.

Brenda Roy, **Child Support**, is interested in the Director position. Salary was discussed as well as a 120-day probation period. Brenda will discuss with Crystal Spearman if she is interested in becoming Deputy Director. Brenda will revamp the position descriptions and give the Commissioners answers on Thursday. This is an unclassified position.
